registered under the Bombay Public Trust Act, 1950, under Registration No. F-42611 (Mumbai)

And

### Patuck-Gala College of Commerce & Management,

registered under the Bombay Public Trust Act, 1950, under Registration No. E-619 (B)

The aforesaid institutions are hereinafter referred to individually – former as NGO and later as Institute and collectively as organizations.

#### Preamble

Whereas, Patuck-Gala College and Ekta Foundation have many areas of common interest in the area of community service, considerable advantage may be gained from their pursuit on a collaborative basis in the field of social work.

Now therefore, Patuck-Gala College and **Ekta Foundation** have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the co-operation of the twoorganizations.

### Clause 1: Object

Both Institutes agree to the conduct of collaborative activities in the following areas:

- President of the NGO to be a Member of the Patuck Gala College CDC (College Development Committee) for a term of 5 years beginning from AY:2019-20
- Students of the College to join / complete Internship program at the NGO
- Sponsorship towards Research undertaken by students andteachers

### Clause 2: Agreement

Patuck-Gala College and Ekta Foundation agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two organizations.

These terms shall include a technical description of the proposed activity, financialarrangements, and person(s) responsible for itsimplementation.

## Clause 3: Validity

The Memorandum shall remain inforce for a period of Five years commencing from the effective above mentioned date. Organizations may extend the term by written agreement signed by both after review.

### Clause 4: Termination

Either organization may terminate the MoU by giving written notice of two months in advance to the other organization. Once terminated, neither Patuck-Gala College nor **Ekta Foundation** will be responsible for any losses, financial or otherwise, which the other organization may suffer. However, Patuck-Gala College and **Ekta Foundation** will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

### Clause 5: Amendments / Modifications

This MoU may be amended or modified by a written agreement signed by Signatories of both Organizations of this MoU.

### Clause 6: Legal Right

Nothing in this Memorandum shall be construed as creating any legal relationship between the Organizations. This Memorandum is a statement of intent to foster genuine and mutually beneficial academic – societal collaboration.

### Clause 7: Dispute Resolution

In case, there be a dispute relating to any aspect of academic – societal co-operation, Heads of Institutes, namely, Patuck-Gala College and **Ekta Foundation** will jointly resolve the dispute in a spirit of independence, mutual respect, and sharedresponsibility.

Patuck-Gala College and Ekta Foundation welcome the establishment of this Memorandum for co-operation and jointly agree to the provisions as set out above.
