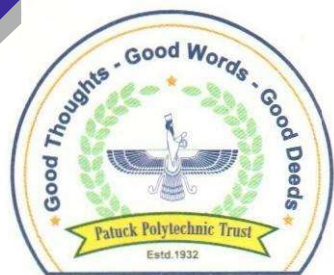

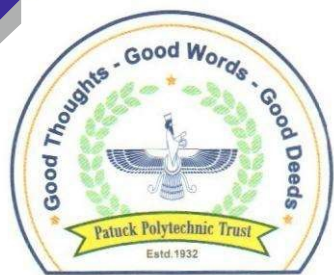

The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutes.

**Preamble**

Whereas, Patuck-Gala College and B. L. Amlani College, have many areas of common interest in the Faculty of Commerce, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of education and research.

Now therefore, Patuck-Gala College and B. L. Amlani College, have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the co-operation of the two institutes.

**Clause 1: Object**

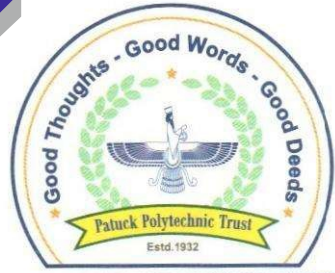
Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.

The two institutions shall seek to promote:

**Academic Collaboration**

Patuck-Gala College and B. L. Amlani College agree that the academic collaboration will be guided by principles listed below:

- Exchange of students by mutual agreement between both the institutes.
- Exchange of faculty members by mutual agreement between both the institutes.

- d. Conducting and participating in webinars/ seminars/ conferences, etc. as a joint collaboration.
- e. Any other academic endeavor that augments the students and faculty skills and capability as mutually agreed upon.

### Clause 2: Agreement

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration which will be agreed upon mutually. Terms and conditions for each assignment or such exchange, including those concerning remunerations, and travel funding will be mutually worked out between the two institutes.

### Clause 3: Co-ordination

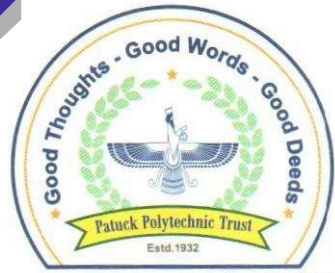
Each institution shall appoint one member of its teaching faculty to coordinate the programme on its behalf. Further, a Coordination Committee consisting of a programme coordinator from the side of Patuck-Gala College, and a programme coordinator from the side of B. L. Amlani College, will periodically review and identify ways to strengthen co-operation between the two institutes.

### Clause 4: Validity

The Memorandum shall remain in force for a period of Two years commencing from the effective above mentioned date. Institutions may extend the term by written agreement signed by both after review.

### Clause 5: Termination

Either institution may terminate the MoU by giving written notice of six months in advance to the other institute. Once terminated, neither Patuck-Gala College and B. L. Amlani College, will be responsible for any losses, financial or otherwise, which the other institutes may suffer. However, Patuck-Gala College and B. L. Amlani College, will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

Participating staff members and students involved in any activities under this Memorandum must adhere to the rules and regulations of the institutes.

**Clause 8: Legal Right**

Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

**Clause 9: Dispute Resolution**

In case, there be a dispute relating to any aspect of academic co-operation, Heads of Institutes, namely, Patuck-Gala College and B. L. Amlani College, will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

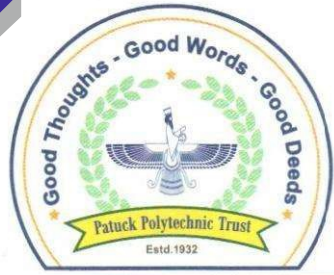

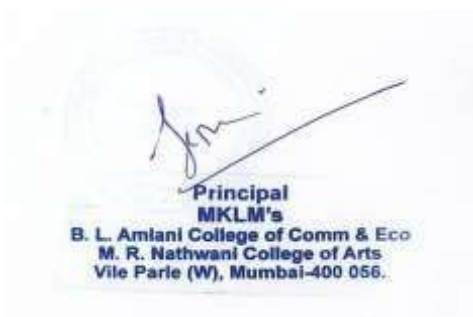

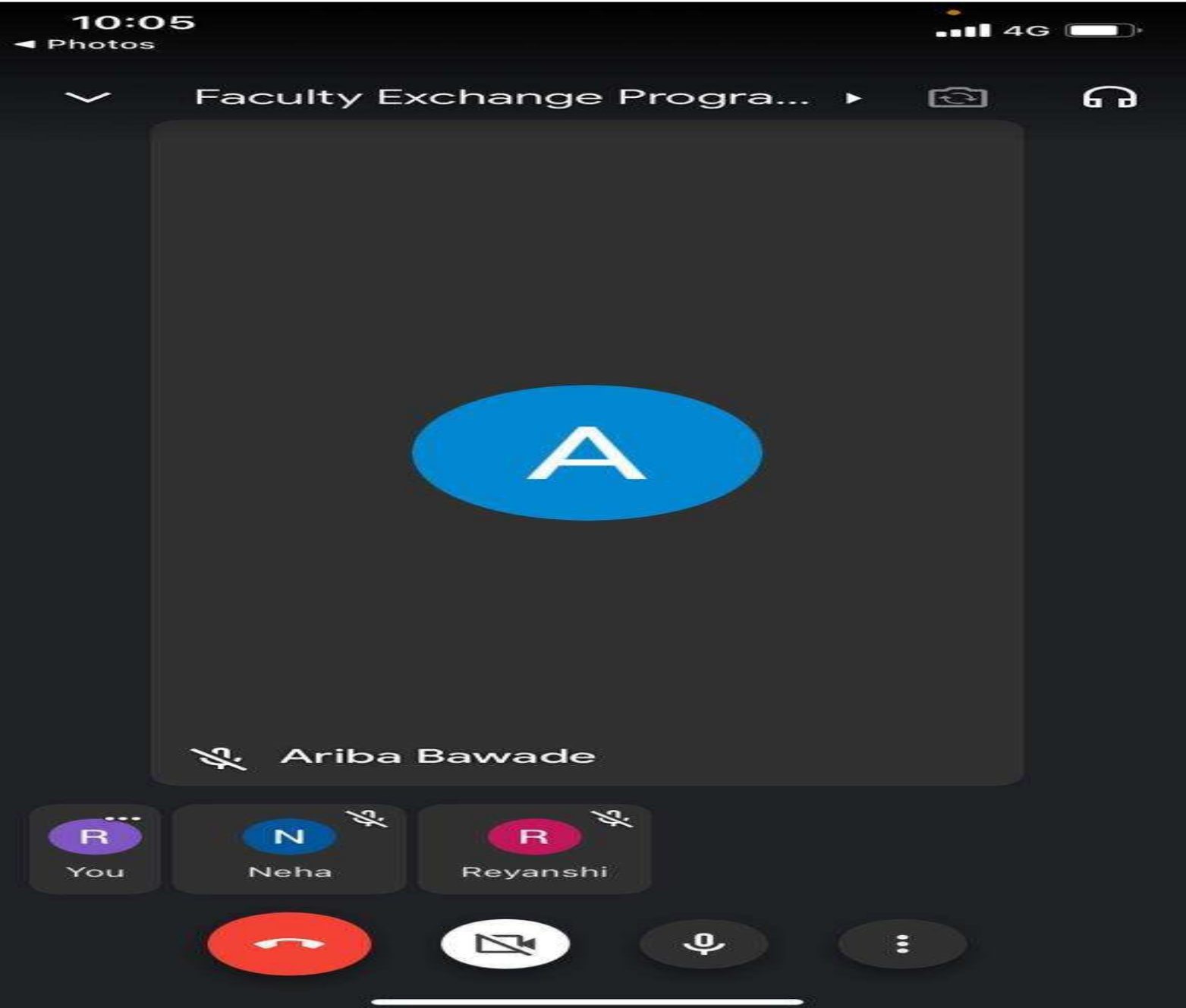

## Memorandum of Understanding

Between

Erin Kelley<sup>1</sup>, Gregory Lane<sup>2</sup> and Gaurav Chiplunkar<sup>3</sup>

and

Patuck-Gala College of Commerce and Management

This Memorandum of Understanding (MOU) sets the terms and understanding between Kelley, Lane and Chiplunkar (hereby mentioned as the "Research Team") and Patuck-Gala College of Commerce and Management (hereby mentioned as the "College") to explore mutually beneficial academic research about labour force participation of final year university students.

Given the current situation due to the COVID-19 pandemic, the program will be altered as required to ensure the safety of all participants and the research team. In accordance with government mandates, the "Research Team" will determine whether it is safe to conduct the training and follow-up sessions in person. If not, the "Research Team" will make arrangements to conduct all sessions virtually, with the implication of changes in course content to best suit it for an online engagement.

There are no legal implications of this MOU.

### Background

We are a team of researchers in development and labor economics from the World Bank, American University and University of Virginia. We have collaborated on projects with companies around the world—Kenya, India, Bangladesh, and the United States. Our work focuses on job-search and firm dynamics. We have extensive experience running randomized control trials and analyzing large, spatio-temporal datasets. We have spent the last four years working with job portals, SMEs and skill assessment companies, educational institutes, and the NSDC in India.

### Objective

The purpose of this research is to investigate how to boost labor force participation among Indian youth. The main hypothesis we would like to test is whether providing more support to young adults through employability and soft skills programs, achieves this objective. To

this end, we have partnered with Talerang to train students in their final year of college on specific job employability skills.

**The “Research Team” agrees to the following commitments:**

1. We are a team of researchers that have raised independent funds to provide job-employability training free of charge. **These programs require no financial commitments from your college or your students.**
2. We have partnered with Talerang, a leader in the provision of career training to students and professionals across India. Talerang will **oversee the introduction of their trademark employability and soft skills programs designed to facilitate job acquisition.**
3. Talerang has trained facilitators that will travel to the “College” to provide scientifically designed job training modules to your students.
4. These programs will be conducted at the “College” premises/virtually with the aim of increasing **the likelihood of appropriate placements for students.**
5. The “Research Team” will then conduct detailed surveys with your students to determine the benefits of these programs on the students. **We will share our finding with the “College”.**

**The “College” agrees to the following commitments:**

**1. Pre-training commitments**

- a. Providing a register of all final year students across degree courses for which the training will be implemented.
- b. Organizing a registration camp on the campus/virtually where all students should register themselves for the training.
- c. Informing registered students that attendance in the program is mandatory and ensuring that students turn up on the day of the training and all other touchpoints thereafter.
- d. Facilitating data collection activities:
  - i. Facilitate the organisation of a first survey (a “baseline survey”) around one month before the training date – “Research Team” to conduct baseline survey with all students on some date before the main training.
- e. Setting up a strong communication point between the “College” and the “Research Team”. These individuals from the “College” will be responsible for coordinating logistics.

**2. Post-training commitments**

- a. Facilitating data collection activities:
  - i. Organising follow-up surveys for training participants - on a predetermined day every week, students to complete follow-up surveys either via gathering in a computer lab or via virtual follow-up sessions

- b. Ensuring that students remain responsive over the entire program period of about 2 months - which includes the baseline survey, the training session, and the post training engagement (job information and follow-up surveys).
  - i. In this regard, the "College" may choose to incentivise students by using levers like attendance, grace marks, refundable deposits, etcetera
  - ii. "College" staff to assist the "Research Team" in reminding students of their sessions

**3. Allow the "Research Team" to collect data**

- a. Collect information on students' job search patterns and behavior on the job market through baseline, midline and endline surveys.

**Reporting**


The "Research Team" will communicate to ensure the steps agreed upon in this MOU will be taken in a mutually satisfactory way.

**Funding**

This MOU is no commitment to funds from either side. The "College" will NOT bear any monetary charges for the employability and soft skills program.

**Duration**

This MOU is at-will and may be modified by mutual consent of the "Research Team". This MOU shall become effective upon signature by the authorized persons and will remain in effect until modified or terminated by any one of the partners by mutual consent.



## LETTER OF COMPLETION AND ACKNOWLEDGEMENT

### Employability Training Project

To Whom It May Concern,

We are a team of researchers in development and labour economics – Dr Erin Kelley from the World Bank, Dr Gregory Lane from American University and Dr Gaurav Chiplunkar from the University of Virginia. We collaborated with **Patuck Gala College of Commerce & Management** to explore mutually beneficial academic research about labour force participation of final year university students.

The purpose of this research was to investigate how to boost labour force participation among Indian youth. The main hypothesis we tested was whether providing more support to young adults through a soft skills and employability training program, achieves this objective. To this end, we partnered with Talerang who trained students in their final year of college on specific work-readiness skills.

- We engaged with a total of **27** students from the **BCOM, BBI, BMS** streams.
- During the course of the program, multiple activities were conducted with these students, including: i. an orientation (to familiarize students with the objectives of the program and take registration), ii. baseline survey (where we collected information on students' job aspirations and preferences), iii. a one-day training workshop (on interview training, work-readiness, and CV building skills delivered by trained professionals from Talerang), iv. weekly check-ins (an optional task for students to learn more about current affairs and report writing, which also enabled the research team to stay informed of students' progress with job search), and lastly, v. a final feedback session. Students who completed all these sessions have already received a digital certificate from our team.
- Owing to the COVID-19 pandemic, safety of the students and our team was central in our planning and logistics. Thus, all components of the program were delivered virtually via SMSes/WhatsApp messages, phone calls, Zoom/Google Meet video calls and over email.

The activities conducted over the last 3 months were in line with the research team's hypotheses of increasing the likelihood of appropriate placements for students. These hypotheses will be validated as the research team rigorously analyses the collected data in the next few months. A report of the final findings will be shared with the college.

We thank the college for their continued cooperation and their assistance in facilitating this research study.

This Memorandum of Understanding (MOU) sets the terms and understanding between Kelley, Lane and Chiplunkar (hereby mentioned as the "Research Team") and Patuck - Gala College of Commerce and Management (hereby mentioned as the "College") to explore mutually beneficial academic research about labour force participation of final year university students.

There are no legal implications of this MOU.

**Background**

We are a team of researchers in development and labor economics from the World Bank, American University and University of Virginia. We have collaborated on projects with companies around the world—Kenya, India, Bangladesh, and the United States. Our work focuses on job-search and firm dynamics. We have extensive experience running randomized control trials and analyzing large, spatio-temporal datasets. We have spent the last three years working with job portals, SMEs and skill assessment companies and the NSDC in India.

**Objective**

The purpose of this research is to investigate how to boost labor force participation among Indian youth. The main hypothesis we would like to test is whether providing more support to young adults through employability and soft skills programs, achieves this objective. To this end, we have partnered with Talerang to train students in their final year of college on specific job employability skills.

2. We have partnered with Talarang, a leader in the provision of career training to students and professionals across India. Talarang will **oversee the introduction of their trademark employability and soft skills programs designed to facilitate job acquisition.**
3. Talarang has trained facilitators that will travel to the "College" to provide scientifically designed job training modules to your students.
4. The program will provide a subset of the student participants with a weekly feed (over a period of 4 weeks) of job vacancies which will be suited to their profile and interests.

- b. Ensuring that students remain responsive over the entire program period of about 2 months - which includes the baseline survey, the training session, and the post training engagement (job information and follow-up surveys).



- i. In this regard, the "College" may want to incentivise students by using levers like attendance, grace marks, refundable deposits, etcetera
3. Allow the "Research Team" to collect data
- a. Collect information on students' job search patterns and behavior on the job market through baseline, midline and endline surveys.







To Whom It May Concern,

We are a team of researchers in development and labor economics - Erin Kelley from the World Bank, Gregory Lane from American University and Gaurav Chiplunkar from the University of Virginia. We collaborated with **Patuck Gala College of Commerce & Management** to explore mutually beneficial academic research about labour force participation of final year university students.

The purpose of this research was to investigate how to boost labor force participation among Indian youth. The main hypothesis we tested was whether providing more support to young adults through a soft skills and employability training program, achieves this objective. To this end, we partnered with Talerang who trained students in their final year of college on specific work-readiness skills.

- We engaged with a total of 37 students from the BBI, BMS, BCOM streams.
- During the course of the program, multiple activities were conducted with these students, including: i. an orientation (to familiarize students with the objectives of the program and take registration), ii. baseline survey (where we collected information on students' job aspirations and preferences), iii. a one day training workshop (on CV building skills delivered by trained professionals from Talerang), iv. a weekly job feed (a curated list of jobs tailored to students' preferences and interests), and lastly, v. a final feedback session.
- The college was instrumental in providing us with logistical support, including but not limited to - access to computer labs and weekly coordination with students.

The activities conducted over the last 5 months were in line with the research team's hypotheses of increasing the likelihood of appropriate placements for students. These hypotheses will be validated as the research team rigorously analyzes the collected data in the next few months. A report of the final findings will be shared with the college.

We thank the college for their continued cooperation and their assistance in facilitating this research study.

## **Preamble**

Whereas, Patuck-Gala College and **Tilak Maharashtra Vidyapeeth (TMV) - Department of Management** have many areas of common interest in the faculty of Management, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academic, education and research.

Now therefore, Patuck-Gala College and TMV (Department of Management) have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the co-operation of the two institutions.

## **Clause 1: Object**

Both Institutes agree to the conduct of a Two-day Student Exchange Program.

A specific plan will be worked out for the activity; setting forth detailed arrangements for collaboration which will be agreed upon mutually. Terms and conditions for each visit or an assignment or such exchange, including those concerning remunerations, travel funding and housing (if needed) will be mutually worked out between the two Institutes.

## Clause 2: Agreement

Patuck-Gala College and TMV (Department of Management) agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two Institutes.

These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

## Clause 3: Co-ordination

A Co-ordination Committee consisting of a Programme Coordinator from the side of Patuck-Gala College, and a Programme Coordinator from the side of TMV (Department of Management) will periodically review and identify ways to strengthen co-operation between the two Institutes.

## Clause 4: Validity

The Memorandum shall remain in force for a period of Two years commencing from the effective above mentioned date. Institutions may extend the term by written agreement signed by both after review.

## Clause 5: Termination

Either institution may terminate the MoU by giving written notice of two months in advance to the other institute. Once terminated, neither Patuck-Gala College nor TMV (Department of Management) will be responsible for any losses, financial or otherwise, which the other institutes may suffer. However, Patuck-Gala College and TMV (Department of Management) will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

Nothing in this Memorandum shall be construed as creating any legal relationship between the Institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial academic collaboration.

## Clause 9: Dispute Resolution

In case, there be a dispute relating to any aspect of academic co-operation, Heads of Institutes, namely, Patuck-Gala College and TMV (Department of Management) will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

registered under the Bombay Public Trust Act, 1950, under Registration No. E-619 (B)

The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutes.

## Preamble

Whereas, Patuck-Gala College and St. Joseph College have many areas of common interest in the faculty of Commerce, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academic, education and research.

Now therefore, Patuck-Gala College and St. Joseph College have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the co-operation of the two institutions.

## Clause 1: Object

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.

The two Institutions shall seek to promote:

## Student Exchange

Patuck-Gala College, Santacruz and St. Joseph College, Virar agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he / she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study or research.

- a. Exchange students will be selected by mutual agreement between the home institution and the host institution.
- b. An exchange student will continue to be treated as full-time student at his / her home institution.
- c. An exchange student will be considered as full-time "exchange" student at the host institution.
- d. The student's programme of study at the host institution will be determined by mutual consultation and agreement between the Teachers of the home institution and that of the host institution.
- e. If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.
- f. If an exchange student has undertaken research, then the home institution will take note of the performance evaluation and the technical report, and take steps in accordance with its own procedures.
- g. Patuck-Gala College, Santacruz and St. Joseph College, Virar agree to provide suitable accommodation, living and travel expenses for student exchange, which may be decided on mutually agreed terms and conditions.

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration which will be agreed upon mutually. Terms and conditions for each visit or an assignment or such exchange, including those concerning remunerations, travel funding and housing will be mutually worked out between the two Institutes.

### Clause 2: Agreement

Patuck-Gala College and St. Joseph College agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two Institutes.

These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

### Clause 3: Co-ordination

A Coordination Committee consisting of a Programme Coordinator from the side of Patuck-Gala College, and a Programme Coordinator from the side of St. Joseph College will periodically review and identify ways to strengthen co-operation between the two Institutes.

#### Clause 4: Validity

The Memorandum shall remain in force for a period of Two years commencing from the effective above mentioned date. Institutions may extend the term by written agreement signed by both after review.

#### Clause 5: Termination

Either institution may terminate the MoU by giving written notice of two months in advance to the other institute. Once terminated, neither Patuck-Gala College nor St. Joseph College will be responsible for any losses, financial or otherwise, which the other institutes may suffer. However, Patuck-Gala College and St. Joseph College will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

#### Clause 6: Amendments / Modifications

This MoU may be amended or modified by a written agreement signed by the representatives of both Institutes.

#### Clause 7: Adherence To Rules

An Exchange Program Committee maybe setup at each end and the composition maybe decided as per the discretion of the respective Institutes.

Participating faculty members, staff and students involved in any activities under this Memorandum must adhere to the rules and regulations of the Institutes.

#### Clause 8: Legal Right

Nothing in this Memorandum shall be construed as creating any legal relationship between the Institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial academic collaboration.

#### Clause 9: Dispute Resolution

In case, there be a dispute relating to any aspect of academic co-operation, Heads of Institutes, namely, Patuck-Gala College and St. Joseph College will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.



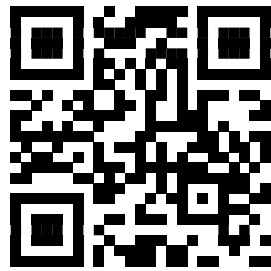
